Call to Order

The meeting was called to order at 7:31 am by president Judith Sorgen

2. Roll Call

3. Approval of Minutes

A motion and second to approve the minutes was made and liaisons voted unanimously to approve.

4. Treasurer's Report

Joan Soth reported on the budget for Cheryl Sutherland. Some guild assessments have yet to be received. Conference revenue is from 2012.

5. Old Business

- a) CNCH 2013 Suzanne Woodhead reported the registration numbers: 191 total, 163 CNCH members, 9 non members, 4 scholarships, 15 committee members. Budget to date is \$57,956.32 with a few small bills to pay. The conference is in the black. Would like to be able to reimburse committee members for 1/2 registration fee and the Thursday night hotel rooms.
- b) CNCH 2014 Judy Fisher reported that the instructors have been secured. Oakland Marriot/Conference Center is the site. The theme: "Branch Out With Fibers" The date April 25 27, 2014. There will be choices for 3,6,9 or 12 hour classes. The liaison luncheon is September 21, 2013 in Oakland. Oakland pursued CNCH for the return conference. It was recommended that CNCH have 2 or 3 conference sites for future conferences. it makes it easier for committees.
- c) Conference Survey Update Kathleen McPherson reported that 76% of the guilds turned in surveys. it was thoughtful feedback. Suggested instructors and classes have been given to future conference committees. CNCH advisory council is looking into accommodating the request to place our large conference in a year opposite HGA Convergence.

6. New Business

a) Email Services - Betsy Gribble described the new email service to members. All members will be entered and will receive an introduction letter. The initial intro will allow folks to opt out of the service. Non members may also sign up. Betsy's email; betsy.gribble@gmail.com

You must keep a record for those. The report is due August 1 of the year. Erin will send out a document to liaisons.

- c) CNCH 2015 Merrie Hewitt introduced Joan Williams who will be her co-chair for the conference. No other information is available at this time.
- d) CNCHnet Outreach Judy Fisher reported on her visit to two guilds to promote the news journal and to request articles. She will resume her outreach program in September to large guilds. her presentation is 15 20 minutes long.
